Description of necessary first-aid measures

If inhaled

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

Store the container tightly closed at room temperature, away from light, dry, and airtight. Store separately from food containers or incompatible materials.
