Description of necessary first-aid measures

If inhaled

## 6. ACCIDENTAL RELEASE MEASURES

1,2-EPOXYOCTADECANE, an epoxide, is sensitive to exposure to moisture. This compound is incompatible with strong acids, caustics and peroxides. (NTP, 1992). Epoxides are highly reactive. They polymerize in the presence of catalysts or when heated. These polymerization reactions can be violent. Compounds in this group react with acids, bases, and oxidizing and reducing agents. They react, possibly violently with water in the presence of acid and other catalysts.
